The Board resumed into the Public Hearing at 7:00 PM. Dr. Chesterton gave a brief overview of the proposed budget for 2010-2011 school year in the amount of \$9,951,049 that will result in 2.28% tax rate decrease for Bridgehampton School District. He talked about the five propositions that will be placed on the ballot for the May 18, 2010 Budget/Election Vote: 1) the proposed budget; 2) monies that will be levied for the Bridgehampton Child Care & Recreational center; 3) bond proposition to replace the windows on the main building of the school district; 4) to provide bus transportation to all students with the Bridgehampton School District up to a distance of 15 miles; and 5) for authorization for the District to receive from the State aid program (EXCEL) that will be applied to offset and reduce taxes.

# III. <u>REPORTS</u>:

- A) Superintendent's Report Dr. Youngblood shared an update on the status of the faculty members that were interested in receiving their CDL License (to assist with driving the District's mini bus.) The only license driver for the bus was Mary Johnsen who will be retiring June 2010. Dr. Youngblood requested that the Board considered hiring a bus driver to provide road experience for them. She said after some research she had found a bus driver that would provide the road assistance at a cost of a maximum of \$400, upon Board approval.
- B) Principal's Report Mr. Pryor presented Haley Lund who gave a brief presentation of her Young leadership Conference to Washington DC.
- C) Interim Business Administrator's Report Dr. Chesterton announced that the Advertisement for a new Business Official was in the Newsday. He also shared that letters was sent to people on the Civil Service List for the Account Clerk position. Mr. Berhalter asked Dr. Chesterton for an update on the Food Service BID Process.

Mr. Berhalter addresses some concerns listed on the Audit committee report, such as the Claims Auditor yearly evaluation and electronic billing.
